LIMITED MEDIA WARRANTY:

If the Software has been delivered by Izenda on physical media, Izenda warrants the media to be free from material physical defects for a period of ninety days after delivery by Izenda. If such a defect is found, return the media to Izenda for replacement or alternate delivery of the Software as Izenda may select.
